3 **ORDINANCE TO ADOPT THE MILLAGE RATE(S) FOR ALL PROPERTY**  
4 **SUBJECT TO TAXATION BY THE PARISH COUNCIL OF WEST FELICIANA**

7 SECTION 1: BE IT ORDAINED The West Feliciana Parish Council of the Parish of  
8 West Feliciana, Louisiana, in a public meeting held on \_\_\_\_\_, which  
9 meeting was conducted in accordance with the Open Meetings Law and the additional  
10 requirements of Article XII, Section 3 of Louisiana Constitution and R.S. 42:11 – 28 [R.S.  
11 42:11, et seq.] that the following millage rate(s) be and they are hereby levied upon the dollar  
12 of each assessed valuation of all property which is subject to ad valorem taxation within said  
13 Parish for the year 2023 for the purpose of raising revenue:

16	Roads, Bridges, Buildings, Parks (1080 005):	8.890 mills
17	Health, Animal, Mosquitoes, Waste, Coroner (1080 007):	1.000 mills
18	Library (1080 027):	1.500 mills
19	Library Bond (1080 026)	0.600 mills
20	Hospital District (1080 028):	0.500 mills

22 SECTION 2: BE IT FUTHER ORDAINED that the proper administrative officials of  
23 the Parish of West Feliciana, State of Louisiana, be and they are hereby empowered,  
24 authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment  
25 roll of said Parish for the year 2023, and to make the collection of the taxes imposed for an  
26 on behalf of the taxing authority, according to law, and that the taxes herein levied shall  
27 become a permanent lien and privilege on all property subject to taxation as herein set forth,  
28 and collection thereof shall be enforceable in the manner provided by law.
